1. This Act may be cited as the International Development short title Association (Food Systems Resilience Program for Eastern and Southern Africa Project - Phase 3) (Authorization) Act, 2023.

2.-(1) The Minister of Finance (the 'Minister'), on behalf of the Authority to Government of the Republic of Malaŵi (the "Government"), is hereby authorized to receive from the International Development Association, a grant in various convertible currencies, not exceeding
