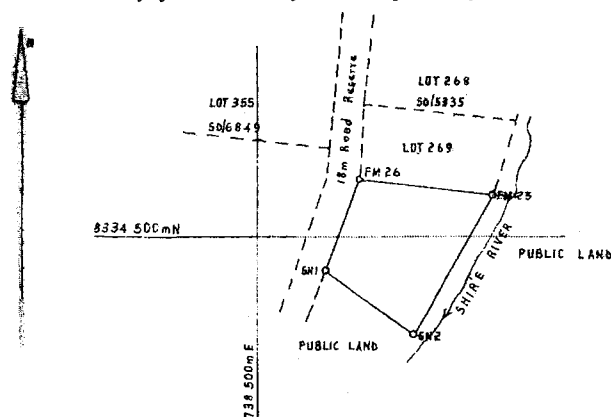
1. THAT you are invited to submit particulars of your respective interests in the property and of the claims made by you in respect thereof.
