WHEREAS it appears to the Minister of the Government of Malawi responsible for Land Matters that all customary land which is situate within the boundaries of the land described in the schedule hereto (the same not being customary land for use as a public road or for the widening or diversion thereof) is needed for public purpose which is for the benefit, direct or indirect, of the community as a whole.


Now THEREFORE, I, YUNUS MUSSA, being the Minister of the Government of Malawi responsible for Land Matters, in exercise of the powers conferred upon me by section 27 subsection 1 of the Land Act, hereby declare that all Customary Land which is situate within the boundaries of the land described in the schedule hereto (the same not being for use as a public road or for the widening or diversion thereof) shall henceforth be public land to be used as a Health Centre.


