IN EXERCISE of the powers conferred on Lilongwe City Council by section 82 of the Local Government Act, I, KELVIN MMANGISA, Chief Executive of Lilongwe City Council, for and on behalf of Lilongwe City Council, hereby notifies all members of the general public that the rates applicable for the purposes of city rates in Lilongwe are as follows—

- (i) In commercial property—0.20 per tambala of property value;
- (ii) In Industrial property—0.17 per tambala per property value;
- (iii) Non-tradition housing property—0.15 per tambala of property value;
- (iv) Tradition Housing area property—0.10 per tambala of the property value.

The rate shall become effective 21 days from the date of publication herein and shall be so applicable until revised.
