Prorogation of Parliament

(Under section 59 (1) (b) of the Constitution)

WHEREAS it is provided in Section 59 (1) (b) of the Constitution of the Republic of Malawi that the President may, in consultation with the Speaker of the National Assembly, prorogue the National Assembly;

AND WHEREAS it is expedient that the National Assembly should be prorogued;

NOW THEREFORE, under and by virtue of the powers vested in me, I PROFESSOR ARTHUR PETER MUTHARIKA, President of the Republic of Malawi, do hereby prorogue the National Assembly from Thursday, 1st October, 2015 to Thursday 5th November, 2015;
