Call for Public Representations on the Proposed Amendment to the Individual Licences to Provide Electronic Communications Services in Malawi Awarded to:

MALCEL PLC.

The Malawi Communications Regulatory Authority (MACRA) would like to inform the public that it intends to amend Malcel plc's Facilities Services Licence, Network Service Licence and Application Service Licence to extend the sollout period of services under those licences by twelve (12) months. The licences will be amended as follows:

Facilities Services Licence

(i) Amend Schedule 1 of the Licence on Rollout Targets as follows:

2. Network Service Licence

- (i) To amend Clause 11.4 of the licence by deleting the words "twelve (12)" after the word "services" and substituting therefor the words "twenty four (24)", to read as follows:
 - "The Licensee shall commence providing network services within twelve (12) twenty four (24) months from the effective date"
- (ii) Amend Schedule 1 of the Licence on Service Coverage by deleting the words "12" (in Phase One implementation target), "24" (in Phase Two implementation target) and "36" (in Phase Three implementation target) "and substituting therefor the words "24", "36" and "48" respectively.

3. Application Service Licence

"The Licensee shall commence providing application Services within twelve (12) twenty four months from the Effective Date.

(ii) To amend Schedule 1 of the Licence on Service Coverage by deleting the words "12" (in Phase One implementation target), "24" (in Phase Two implementation target) and "36" (in Phase Three implementation target) and substituting therefor the words "24", "36" and "48" respectively.

Rationale for the Amendment

The proposed amendment is being made following Malcel Plc's request for a twelve (12) month extension of the period to roll out its services. Malcel Plc. indicated that it could roll out services within the initial rollout period due to force majeure events including global inflationary pressures leading to increased interest rates. The extension will be effective from 14th October 2023, the Effective Date of the licenses issued to Malcel Plc.
