# REQUEST THAT A PORTION OF FARM ROAD 3005 BE DEVIATED: DISTRICT OF TSUMEB

In terms of section 17(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Roads Board of Tsumeb requests that the portion of farm road 3005 described in paragraph (a) of the Schedule and shown on sketch-map P1457 by the symbols G-B-C-D-E, be deviated

from the route so described and shown, to the route described in paragraph (b) of the Schedule and shown on sketch-map P1457 by the symbols G-F-E.

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the road to which the request refers and other proclaimed minor and private roads in that area are shown, shall for the full period of thirty days mentioned below lie open to inspection at the offices of the Permanent Secretary for Works, Transport and Communication, Windhoek, and the Roads Superintendent, Tsumeb, during normal office hours.

Every person having any objection to the above-mentioned request is hereby commanded to lodge his or her objection in writing with the grounds upon which it is based clearly and specifically therein stated, with the Chairman of Roads Boards, Private Bag 12005, Ausspannplatz, 9000, within a period of thirty days from the date of publication of this notice.

#### **SCHEDULE**

- (a) From a point (G on sketch-map P1457) on the common boundary of farms Portion 3 of Elandshoek 771 and Portion 1 of Rooiplaas 772 generally east-north-eastwards across the last-mentioned farm to a point (B on sketch-map P1457) on the last-mentioned farm; thence generally northwards and more and more north-north-westwards across the last-mentioned farm and the farm Portion 3 of Elandshoek 771 to a point (C on sketch-map P1457) on the last-mentioned farm; thence generally east-north-eastwards across the last-mentioned farm and the farm Portion 1 of Rooiplaas 772 to a point (D on sketch-map P1457) on the last-mentioned farm; thence generally northwards across the last-mentioned farm to a point (E on sketch-map P1457) on the common boundary of the last-mentioned farm and the farm Portion 3 of Elandshoek 771.
- (b) From a point (G on sketch-map P1457) on the common boundary of the farms Portion 3 of Elandshoek 771 and Portion 1 of Rooiplaas 772 generally east-south-eastwards and more and more eastwards across the last-mentioned farm to a point (F on sketch-map P1457) on the last-mentioned farm; thence generally north-eastwards and more and more northwards across the last-mentioned farm to a point (E on sketch-map P1457) on the common boundary of the last-mentioned farm and the farm Portion 3 of Elandshoek 771.
