REGULATIONS MADE UNDER THE STATISTICS ACT, 1976 (ACT 66 OF 1976): POPULATION AND HOUSING CENSUS

The President has under section 17 of the Statistics Act, 1976 (Act 66 of 1976), made the regulations set out in the Schedule.

SCHEDULE

1. For the purpose of the taking of a census of the population of the Republic of Namibia and the collection of statistics in relation to housing conditions, the following particulars shall be furnished, in the form framed by the Secretary, in relation to every person who is ordinarily resident in Namibia on midnight between 20 and 21 October 1991 or who otherwise happens to be in Namibia at the said point of time:

A. Particulars in relation to persons -

- (1) Name
- (2) Relationship
- (3) Sex
- (4) Age
- (5) Nationality
- (6) Place of birth
- (7) Place of usual residence
- (8) Disability
- (9) Language spoken
- (10) Literacy
- (11) School attendance
- (12) Educational attainment
- (13) Type of activity engaged in
- (14) Occupation
- (15) Name and address of workplace
- (16) Industry
- (17) Status in employment
- (18) Marital status
- (19) Children ever born alive
- (20) Children living in household
- (21) Children living elsewhere
- (22) Children deceased
- (23) Children born alive during past 12 months
- (24) Children deceased who were born during past 12 months

B. Particulars in relation to housing -

- (1) Type of housing unit
- (2) Tenure
- (3) Number of rooms
- (4) Material used for outer walls
- (5) Material used for roof
- (6) Fuel used for cooking
- (7) Fuel used for lighting
- (8) Fuel used for heating
- (9) Source of water supply
- (10) Type of toilet facility
- (11) Ownership of radio
- (12) Ownership of television
- (13) Purchase of newspaper
- 2. The form referred to in regulation 1 shall be completed by a census enumerator charged with the collection of the statistics referred to in that regulation and any person requested to do so by such census enumerator shall furnish the required statistics to him or her.
- 3. (1) A census enumerator shall, when calling at any dwelling, building or piece of land for the purpose of performing his or her duties in terms of these regulations, affix a sticker provided for that purpuse, and showing a three-digit census number, at any suitable conspicuous place on or at such dwelling, building or piece of land.

- (2) No person shall without the consent of the Permanent Secretary: National Planning Commission remove any sticker affixed by a census enumerator in terms of subregulation 2.
- 4. Any person who, without reasonable cause, contravenes any provision of these regulations or fails to comply therewith, shall be guilty of an offence and liable on conviction to a fine not exceeding R200 or, in the case of a continuing failure to comply therewith, to a fine not exceeding R10 for each day during which the failure continues.
