AGRONOMIC INDUSTRY ACT, 1992: IMPOSITION OF A GENERAL LEVY ON CERTAIN CATEGORIES OF CONTROLLED PRODUCTS

I hereby -

- (a) on the recommendation of the Namibian Agronomic Board, under section 18(1) of the Agronomic Industry Act, 1992 (Act 20 of 1992), with effect from the date of publication of this notice, impose a general levy on certain categories of controlled products as set out in the Schedule; and
- (b) under section 18(3) of that Act abolish the levies imposed under Government Notice 56 of 1986 as amended.

1. A person who produces for his or her benefit wheat, maize or sunflower seeds and sells such seeds shall pay a general levy of 2,6% of the proceeds derived from such sale calculated at the price, as fixed under section 20(1)(a) of the Agronomic Industry Act, 1992 (Act 20 of 1992), at which such a person may sell any such seeds.
 2. Subject to paragraph 4, a person who -
 - (a) imports into Namibia for human consumption wheat or maize seeds or agronomic products which were derived from the grinding, ~~crushing or milling of wheat or maize seeds; or~~
 - (b) purchases for human consumption wheat or maize seeds from a person referred to in paragraph 1,shall pay a general levy of R2,10 per 1 000 kilogram, or part thereof, calculated on the quantity of any such seeds or products so imported or purchased.
 3. Subject to paragraph 4, a person who -
 - (a) imports into Namibia for human consumption sunflower seeds or agronomic products which were derived from the pressing of sunflower seeds; or
 - (b) purchases for human consumption sunflower seeds from a person referred to in paragraph 1,shall pay a general levy of R11,10 per 1 000 kilogram, or part thereof, calculated on the quantity of any such seeds or products so imported or purchased.
 4. The levies referred to in paragraphs 2 and 3 shall not be payable on the importation or purchase of wheat, maize or sunflower seeds intended for planting purposes.
 5. The levies referred to in paragraphs 1, 2 and 3 shall be collected by the Board or such a person or body as may be appointed by the Board to collect the levy on behalf of the Board.
