N\$5.10 handling charge per money order, plus 2.00% commission on the amount (with a maximum amount of N\$100 per money order) plus the telegraph charge at current rates to the country of destination of the telegram sent by the issuing office, plus N\$0.60 notification fee.

N\$10.90 handling charge per money order, plus 2.00% commission on the amount (with a maximum amount of N\$100 per money order) plus the telegraph charge at current rates to the country of destination of the telegram sent by the issuing office.

Tariff

The handling charge and commission mentioned in items 2 and 5 for these services in respect of ordinary money orders, plus-

- (i) in the case of Namibia; N\$3.50 per telegram;
- (ii) in the case of countries not mentioned in paragraph (i), the telegraph charge per word applicable to such countries.

8. For the searching through of accounts in respect of each money order office if the remitter or payee desires information with regard to the issue or payment of a money order but cannot furnish the date of issue of the relative money order.
