# PROPOSAL THAT PORTIONS OF TRUNK ROAD 1/5 AND MAIN ROAD 49 BE CLOSED, AND THAT MAIN ROAD 85 BE CLOSED: DISTRICT OF WINDHOEK

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Windhoek -

- (a) the portion of trunk road 1/5, described in Schedule I and shown on sketch-map P1531 by the symbols A-B-C, be closed;
- (b) the portion of main road 49, described in Schedule II, known as Gamsberg Road and shown on sketch-map P1531 by the symbols F-G-H-C, be closed; and
- (c) main road 85, described in Schedule III and shown on sketch-map P1531 by the symbols D-E, be closed.

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the roads to which the proposal refers and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days, mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek and the Roads Superintendent, Windhoek, during normal office hours.

Every person having any objection to the above-mentioned proposal is hereby commanded to lodge his or her objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Under-Secretary for Transport, Private Bag 12005, Ausspannplatz, within a period of thirty days from the date of publication of this notice.
