# ESTABLISHMENT OF AN AREA AS THE AREA OF A LOCAL AUTHORITY AND DECLARATION THEREOF AS A MUNICIPALITY

Under the powers vested in me -

- (a) by section 3(1) of the Local Authorities Act, 1992 (Act 23 of 1992), I hereby establish the area referred to in paragraph (a) of clause 1(2) of Part III of the Schedule to the Walvis Bay and Off-shore Islands Act, 1994 (Act 1 of 1994), as the area of a local authority and declare such area to be a municipality referred to in Part I of Schedule I of the said Local Authorities Act, 1992, under the name Walvis Bay;
- (b) by section 3(4)(a) of the said Local Authorities Act, 1992, I hereby determine that the municipal council of the municipality referred to in paragraph (a) shall consist of seven members;
- (c) by section 3(4)(b) of the said Local Authorities Act, 1992, I hereby amend Schedule I to that Act by the substitution for Part I of that Schedule of the following part:

### "PART I

1.	Swakopmund	7	
2.	Walvis Bay	7	
3.	Windhoek	12	

"; and

(d) by section 3(4)(d)(i) of the said Local Authorities Act, 1992, I hereby determine that the election for members of the municipal council of the municipality referred to in paragraph (a) shall take place on 15 and 16 August 1994.
