## PUBLIC SERVICE ACT, 1980: AMENDMENT OF REGULATIONS

The President has under section 28 of the Public Service Act, 1980 (Act 2 of 1980) made the regulations set out in the Schedule.

#### SCHEDULE

1. In these regulations "the Regulations" means the Regulations promulgated by Government Notice AG. 28 of 1 April 1981, as amended by Government Notices 90 of 15 May 1986 and 14 of 16 January 1989.

2. Regulation K1 of the Regulations is hereby amended —

(a) by the substitution for the definition of "dependant" of the following definition:

" 'dependant', in relation to a member, means the spouse or any necessarily non-selfsupporting child (including any step child or legally adopted child) of such member;"; and

(b) by the substitution in the definition of "other medical assistance" for the words preceding paragraph (a) of the following words:

" 'other medical assistance' means assistance to which a person is entitled in his or her own right, or as a widow or widower or dependant of such a person on account of his or her services with any body or institution or on account of his or her compulsory membership of any fund or scheme which make provision for -".

3. Regulation K3 of the Regulations is hereby amended by the substitution for paragraph (b) of subregulation 4 of the following paragraph:

"(b) on the day immediately preceding the date on which he or she becomes a dependant of a member of the Scheme;".

4. Regulation K4 of the Regulations is hereby amended by the deletion of subregulation 3.

#### DETERMINATION OF TOTAL ALLOWABLE CATCH IN RESPECT OF PILCHARD, HORSE MACKEREL, HAKE AND CRAB: SEA FISHERIES ACT, 1992

In terms of section 15 of the Sea Fisheries Act, 1992 (Act 29 of 1992), and after consultation with the Sea Fishery Advisory Council, I hereby determine, that -

- (a) the total allowable catch for the year 1995, in respect of the species of fish specified in the first column of the Table below, for the purpose of allocating quotas during the period specified in the second column of that Table opposite each such species, shall be as specified opposite such species in the third column of the Table; and
- (b) notwithstanding the period specified in the second column of the Table in respect of pilchard, the holder of a quota in respect of pilchard may, if the Minister, on application made by such holder, has granted written authority therefor, catch such percentage of the allocated quota during such period or periods falling outside the specified period as may be determined and specified by the Minister in such written authority.
