CLOSING OF A TRUNK ROAD, PORTION OF TRUNK (8/4) AND DISTRICT ROADS, AND THE DECLARATION OF PROCLAIMED ROADS, A TRUNK ROAD AND DISTRICT ROADS: DISTRICT OF KAVANGO

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has -
  - (i) under section 22(1)(c) of the said Ordinance closed the roads described in -
    - (aa) the Schedule to Government Notice A.G. 150 of 1983 and shown on sketch-map P1108;
    - (bb) Schedules III; V; XII; XIII; XIV; XV; XVI; XVII; XVIII; XIX and XX to Government Notice A.G. 33 of 1985 and shown on sketch-map P1152;
    - (cc) Schedules IV; V: X and XII to Government Notice 103 of 1987 and shown on sketch-map P1301;
    - (dd) the Schedule to Government Notice 132 of 1988 and shown on sketch-map P1375;
    - (ee) the Schedule to Government Notice 81 of 1990 and shown on sketch-map P1416; and
    - (ff) the Schedule to Government Notice 1 of 1992 and shown on sketch-map P1479; and
  - (ii) under section 22(1)(b) of the said Ordinance .
    - (aa) declared the road described in Schedule I and shown on sketch-map P1523 by the symbols A1-B1-A2-C-A3-D1-A4-E-A5-A6-A7-G-H-A8-K-A9-L-A10-M-N-A11-O-A12-P-A13-Q-R-S-A14-T-U-A15-A16-V1-A17-A18-B30-W-A19 to be a proclaimed road; and
    - (bb) declared the roads described in Schedules II to XXV and shown on sketch-map P1523 by the symbols B1-B2-B3-B4-B5-C1-B6-B7-D2-E1-B8-B9-B10-B11-F-B12-G1-B13-B14-H1-B15-B16-J4-B17-K1-L1-M1-M2-B18-N1-O1-O2-B22-B23-P1-Q2-R1-B24-B25-S2-T1-U1-B26-B27-B28-B29-B30; C-C1; D1-D2-D3; E-E1; A7-F; G-G1; H-H1; J-J1-J2-J4; K-K1; L-L1; M-M1; M2-M3; N-N1; O-O1; O2-O3; P-P1; Q-Q1-Q2; R-R1; S-S1-S2; T-T1; U-U1; X-X1; V-V1-V2-V3-V4; and W-W1-W2-W3, respectively, to be proclaimed roads; and

- (b) in terms of section 23(3) of the said Ordinance that the Minister has -
  - (i) under section 23(1)(a) of the said Ordinance declared the road referred to in paragraph (a)(ii)(aa) to be a trunk road (number 8/4); and
  - (ii) under section 23(1)(c) of the said Ordinance declared the roads referred to in paragraph (a)(ii)(bb), respectively, to be district roads, in every case with the number stated in the particular Schedule.

The said sketch-map shall at all times lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.

AMENDMENT OF REGULATIONS UNDER THE CASINO'S AND GAMBLING HOUSES ACT 1994 (ACT 32 OF 1994)

The Minister of Environment and Tourism has, under section 54 of the Casino's and Gambling Houses Act, 1994 (Act 32 of 1994), amended the regulations promulgated by Government Notice 231 of 1994, as set out in the Schedule.

#### SCHEDULE

1. In this Schedule "the regulations" means the Regulations under the Casinos and Gambling Houses Act 1994, (Act 32 of 1994) promulgated by Government Notice 231 of 2 December 1994.

2. Regulation 10 of the regulations is hereby repealed.

3. Regulations 16 of the regulations is hereby amended by the substitution for subregulation (1) of the following subregulation:

"(1) Upon the submission of an application in terms of section 16, 26 or 38 of the Act the applicant shall pay to the secretary the appropriate fee set out in Part I of Annexure B."

4. Regulation 17 of the regulations is hereby amended -

- (a) by the substitution in subregulation (1) of the words "has been paid to the Receiver of Revenue" of the words "is paid to the secretary"; and
- (b) by the substitution in subregulation (2) for the words "Receiver of Revenue" of the word "secretary".

5. Regulation 18 of the regulations is hereby amended by the substitution for the words "has been paid to the Receiver of Revenue" of the words "is paid to the secretary".

6. Regulation 19 of the regulations is hereby amended by the substitution for the words "has been paid to the Receiver of Revenue" of the words "is paid to the secretary".

7. The following regulation is hereby substituted for regulation 20 of the regulations:

#### "Levy payable by licence holders

20.(1) The levy imposed by section 41 of the Act shall be calculated and be payable by the holder of a licence of the nett monthly income which such holder derives from the conduct of the casino or gambling house, as the case may be, at the rate of -

- (a) 5 per cent of such income in respect of the first period of 12 months calculated from the date of issue or, where applicable, the date of transfer of the licence to the holder thereof;
- (b) 10 per cent of such income during the second period of 12 months; and
- (c) 15 per cent of such income in respect of the third and each subsequent such period of 12 months.

(2) For the purposes of subregulation (1) "nett income" means the gross income derived from gambling operations in the casino or gambling house (excluding income from the sale of liquor or food or other commodities on the premises) during the month concerned less only the total amount paid out by such holder as winnings during such period.

(3) The amount due in respect of the levy calculated and payable in accordance with subregulations (1) and (2) shall -

- (a) be paid to the secretary not later than 21 days after the end of the month in respect of which the levy is payable; and
- (b) be accompanied by a statement showing the gross amount earned from gambling operations during the month concerned and the amount paid out as winnings during such month.

(4) If the holder of a licence ceases to conduct the casino or gambling house, as the case may be, during the course of a month, the levy payable in respect of such month shall be calculated on the nett income derived until the date on which such holder ceased to conduct the business concerned, and the amount so payable shall be paid to the secretary not later than 21 days after the date on which the holder ceased to conduct the business.".

8. The following regulation is hereby substituted for regulation 21 of the regulations:

"Penalties for late payment of annual licence fee or levy.

21. Without prejudice to the provisions of section 24 of the Act, if the amount payble in terms of these regulations in respect of the annual licence fee or of the levy imposed by section 41 is not paid in full to the secretary before the expiry of the period allowed by these regulations for the payment of such fee or such levy, the licence holder concerned shall pay a penalty equal to 10 per cent of the outstanding amount for each month or part of a month that such amount remains outstanding.".

9. The following regulation is hereby substituted for regulation 23 of the regulations:

#### "Terms and conditions applicable to gambling house licences

23.(1) No gambling machines provided for the purpose of gambling on premises licensed as a gambling house shall be kept at any place other than the area or areas as indicated on the plan of the premises submitted in terms of regulation 3(2)(b).

(2) If the area or any of the areas referred to in subregulation (1), is not a separate room, such area shall at all times be screened off from the remainder of the premises in such a manner that it will not be possible to observe from outside such area the gambling activities carried on therein, and every such room or screened off area shall be provided with a door that can be closed in order to control the entrance of persons thereto: Provided that where any gambling machines are kept in any bar conducted on the premises under an on-consumption licence issued under the Liquor Ordinance, 1969 (Ordinance 2 of 1969), it shall not be required that the area concerned be so screened off if the room or section of the premises comprising the bar is so separated from the remainder of the premises that it will not be possible to observe from outside the bar the activities carried on therein.

(3) No change to the number of areas comprising the gambling house in the licensed premises or to the location of any such area on such premises or any other structural alterations to such premises affecting the number of those areas or the location of any such area on such premises shall be effected, unless plans indicating the proposed changes or alterations have been submitted to the Minister and the Minister, acting on a recommendation of the board, has approved such plans.

- (4) The holder of a gambling house licence shall not -
- (a) keep in the gambling house, for the purpose of gambling, any gambling machines in excess of the number specified in the licence concerned, and which licence shall not be granted in respect of more than 10 gambling machines, unless the Minister, acting on a recommendation of the board, decides otherwise, but in no case shall a licence be granted in respect of more than 20 gambling machines;
- (b) offer any prize in excess of N\$10 000 to be won, whether by means of the operation of a single gambling machine or two or more gambling machines linked for the purpose of gambling.

(5) Subject to subregulation (6), no gambling machine shall be kept in any gambling house unless -

- (a) it operates by means of electrical power;
- (b) it is played by means of the insertion of coins or playing chips in a slot in the machine provided for the purpose; and
- (c) it is capable of keeping accurate record of the amounts played and the amounts paid out as prizes.

(6) The holder of a gambling house licence shall not in the gambling house use or allow to be used any gambling machine unless -

- (a) it is marked with a permanent and ineffeceable serial number; and
- (b) it has been registered with the secretary.
- (7) The holder of a gambling house licence shall not -
- (a) allow any person to enter the gambling house, unless he or she is properly dressed;
- (b) permit any person to remain in the gambling house if he or she is notably under the influence of alcohol or a drug having a narcotic effect or, through the use of foul language or disorderly behaviour, causes a nuisance to other persons in the gambling house.

(8) The holder of a gambling house licence shall keep such books of account and records relating to the operation of the gambling house as are necessary to reflect in respect of each gambling machine the total daily amount played and the total daily amount paid out.

(9) Every holder of a gambling house licence shall in respect of each period of six months ending on 31 March and 30 September of each year prepare a statement showing the gross takings of the gambling house and the amount paid out as prizes during such period and lodge such statement with the secretary not later than 14 days after the expiry of such period.

(10) The holder of a gambling house licence shall not keep the gambling house open for gambling or allow any person to be present therein for the purpose of gambling at a time when the sale or supply of liquor is not permitted by the liquor licence which such holder holds in respect of the accommodation establishment or retail liquor business, as the case may be.".

- 10. Regulation 24 of the regulations is hereby amended -
- (a) by the substitution for subregulation (1) of the following subregulation:

"(1) Where it is indicated in an application for the grant or removal of a casino licence or the transfer of a casino licence that the applicant, if the application is granted, intends to offer in the casino concerned a prize that can be won through the playing of a single gambling machine or two or more gambling machines linked for that purpose, the amount or value of which will exceed N\$10 000, the Minister, acting on a recommendation of the board and with due regard to the maximum value of the prize that will be offered to be won, may, when granting the application, require from the applicant to furnish to the secretary a guarantee for the due and punctual payment of such prize to any person who may become entitled thereto and may, after consultation with the applicant, determine the amount for which and the manner and form in which, the guarantee is to be furnished."; and

(b) by the addition of the following subregulation:

"(3) If at any time after the grant or transfer of a casino licence the holder of such licence intends to introduce a scheme whereby a prize as contemplated in subregulation (1) is offered, such licence holder shall not introduce such scheme unless he or she has in writing notified the Minister accordingly and, where so required by the Minister on the recommendation of the board, has furnished to the secretary a guarantee as contemplated in subregulation (1)."

11. The following regulation is hereby added to the regulations:

#### "Prohibition against jackpot prize linked to scheme outside Namibia

25. No holder of a casino licence or gambling house licence shall, for the purpose of offering a cumulative jackpot prize, participate in any scheme whereby any gambling machine provided by such holder is linked to any gambling machine or machines outside Namibia.".
