DETERMINATION OF LOCATION AND EXTENT OF WALVIS BAY EXPORT PROCESSING ZONE

Under section 19(2) of the Export Processing Zones Act, 1995 (Act 9 of 1995), and in consultation with the Minister of Finance and the local authority of Walvis Bay, I hereby determine the location and extent, and define the boundaries, of the area of the Walvis Bay Export Processing Zone established by section 19(1) of that Act, as follows:

The area of the Walvis Bay Export Processing Zone shall be the area comprising the following properties situated within the municipality of Walvis bay:

- (a) Erf 1592 Walvis Bay, 15,706 square metres in extent;
- (b) erf 2886 Walvis Bay, 17,219,5 square metres in extent;
- (c) a portion of erf 3427 Walvis Bay, 8,023 square metres in extent;
- (d) erf 3447 Walvis Bay, 30,786 square metres in extent;
