SEA FISHERIES ACT, 1992: INCREASE OF TOTAL ALLOWABLE CATCH IN RESPECT OF HAKE

In terms of section 15 of the Sea Fisheries Act, 1992 (Act 29 of 1992) and after consultation with the Sea Fishery Advisory Council, I hereby determine that the total allowable catch for the year 1996 determined by me in respect of hake, and as specified in Government Notice 235 of 15 December 1995, shall be increased from 150 000 metric tons to 160 000 metric tons.

SEA FISHERIES ACT, 1992: DETERMINATION OF TOTAL ALLOWABLE CATCH IN RESPECT OF PILCHARD

In terms of section 15 of the Sea Fisheries Act, 1992 (Act 29 of 1992), and after consultation with the Advisory Council, I hereby determine that -

- (a) the total allowable catch available for the allocation of quotas for directed pilchard catches to be caught during the period 1 May 1996 up to and including 31 August 1996, shall be 20 000 metric tons;
- (b) notwithstanding the period specified in (a) above, the holder of a quota in respect of pilchard may, if the Minister, on application made by such holder, has granted authority therefor, catch such percentage of the allocated quota during such period or periods falling outside the specified period as may be determined and specified by the Minister in such written authority;
- (c) paragraph (a) shall not apply in respect of pilchards caught for use as bait by boats authorized by the Minister to do so, during the period 1 September up to and including 28 February, in quantities which shall not exceed 500 metric tons.
