PROPOSAL THAT A DISTRICT ROAD BE PROCLAIMED  
(NUMBER 580), THAT A PORTION OF FARM  
ROAD 564 BE CLOSED AND THAT THE CLASSIFICATION  
OF PORTIONS OF FARM ROAD 564 BE CHANGED TO  
DISTRICT ROAD 580: DISTRICTS OF KARASBURG AND  
KEETMANSHOOP: KARAS REGION

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the districts of Karasburg and Keetmanshoop -

- (a) a district road be proclaimed on land where no road previously existed as described in Schedule I and shown on sketch-map P1579 by the symbols C-D-E-F1;
- (b) the portion of farm road 564 described in Schedule II and shown on sketch-map P1579 by the symbols C-G-H-J-F1, be closed; and
- (c) the classification of the portions of farm road 564 described in Schedules III and IV and shown on sketch-map P1579 by the symbols A-B-C and F1-F, respectively, be changed to district road 580.

A copy of this notice and the said sketch-map on which the road to which the proposal refers and other proclaimed, minor and private roads in the area are shown, shall for the full period of 30 days mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendents, Karasburg and Keetmanshoop, during normal office hours.

Under section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance 11 of 1963), I hereby declare the area situated on Portin 4 of Ongwediva Town and Townlands 881 in the Town Area of Ongwediva, Registration Division A, and represented by General Plan A100 (A420/95) to be an approved township.

The conditions subject to which the application for permission to establish the township concerned has been granted, are set forth in the Schedule below in terms of section 13.

### **SCHEDULE**

#### **1. Name of township**

The township shall be called Ongwediva (Extension 3).

## **2. Composition of township**

The township comprises 93 erven numbered 3005 to 3097, and streets as indicated on General Plan A100 (A420/95).

## **3. Reserved erven**

Erven 3095, 3096 and 3097 are reserved for the Town Council of Ongwediva for general local authority purposes.

## **4. Conditions of title**

The following conditions shall be registered in favour of the Town Council of Ongwediva against the title deeds of all erven, except the erven referred to in paragraph 3:

- "(a) The erf shall be used for residential purposes only.
- (b) The building value of the main building, including the outbuildings, to be erected on the erf shall be at least two times the prevailing valuation of the erf by the Town Council of Ongwediva.
- (c) There shall be no obstruction or deviation of any natural course of storm water over the erf without the written approval of the Town Council of Ongwediva.
- (d) The erf is subject to the reservation for the Town Council of Ongwediva of the right of access and use without compensation of the area three metres parallel with any boundary of such erf, for the construction and maintenance of local authority services in respect of water, sewerage, drainage, electricity and gas, which right includes the right to place on such erf temporarily any material that may be excavated during such operation on the erf or any adjacent erf.
- (e) If the erf has more than one street frontage, access to such erf shall be obtained from the street determined by the Town Council of Ongwediva.
- (f) No offensive trade whatsoever shall be established or conducted on the erf.

For purposes of this paragraph 'offensive trade' means any of the businesses, trades, works or institutions mentioned in regulation 1(a) of the regulations promulgated under Government Notice 141 of 1926.



- (g) No cattle, pigs, goats, sheep, donkeys, monkeys, beasts of prey or draught-animals shall be kept or allowed on any erf."
