#### **SCHEDULE**

## BOUNDARY DESCRIPTION OF THE NYAE NYAE CONSERVANCY SITUATED IN THE TSUMKWE DISTRICT - OTJOZONDJUPA REGION

The point of beginning is at the North East corner of the Conservancy - 21° 00 ' 00 " E and 19° 10 ' 00" S and has the same situation as the South East corner of the Khaudum Game Park and is further situated on the common boundary between Namibia and Botswana.

From the point of beginning Southwards along the common boundary between Namibia and Botswana to a point at 20° 00 ' 00" S on said common boundary, from there Eastwards along the Veterinary fence to the point where a North South track intersects the Veterinary fence at 19° 54 ' 00" E, thence along said track in a Northerly direction up to the borehole known as !Am!'ha at 19° 52 ' 47" E and 19° 37 ' 21 " S, thence in a North Easterly direction in a straight line to the borehole known as Tjeka at 20° 06 ' 47 " E and 19° 34 ' 21 " S, thence in a Northerly direction along a track until the track intersects with the main Tsumkwe - Grootfontein road to the middle of said road at 20° 06 ' 47 " E and 19° 30 ' 21 " S, thence Eastwards, following the centre of the main road, to a point of intersection with 20° 14 ' 00" longitude, thence in a Northerly direction to the point 20° 14 ' 00" E and 19° 17 ' S, thence in a North - Easterly direction to a point at 20° 25' 00" E and 19° 10 ' 00" S, thence in a Easterly direction towards and then along the Southern boundary of the Khaudum Game Park to the point of beginning.

Exempted from the area is what is going to be proclaimed as Tsumkwe village by the Ministry of Regional and Local Government and Housing. This area which is to be proclaimed is 30 sq km. A rough outline of the area is shown on the attached map. The Nyae Nyae Conservancy consists of an area of 9023 sq km.

#### ROAD TRAFFIC ORDINANCE, 1967: COMPULSORY PRESENTATION FOR INSPECTION OF MOTOR VEHICLES AND SUBMISSION OF IDENTITY CARDS AND MOTOR VEHICLE LICENCES: WINDHOEK REGISTERING AUTHORITY AREA

Under section 55B of the Road Traffic Ordinance, 1967 (Ordinance 30 of 1967), I hereby determine that -

- (a) the owner of a motor vehicle registered in the Windhoek registering authority area shall, for the purpose of a physical inspection by a road transportation inspector of such motor vehicle as contemplated in section 55B(1) of that Ordinance, in person present such motor vehicle at the Data Capture Facility, Birmingham Street, Northern Industrial Area, WINDHOEK, between 08h00 and 17h00 on any day during the applicable period of time for compulsory inspection of motor vehicles specified in the Schedule, excluding -
  - (i) any public holiday referred to in, or declared under, the Public Holidays Act, 1990 (Act No. 26 of 1990); or
  - (ii) any Saturday or Sunday;
- (b) if as a result of -

.:

- (i) the absence from the Windhoek registering authority area of any owner, or of any motor vehicle, referred to in paragraph (a), during the applicable period of time for compulsory inspection of motor vehicles specified in the Schedule; or
- (ii) the inability, for any reason acceptable to the Under Secretary of the Department of Transport (hereafter referred to as the Under Secretary), of any owner referred to in subparagraph (i) to present any motor vehicle referred to in that subparagraph for inspection as contemplated in paragraph (a); or

(iii) such other exceptional circumstances as the Under Secretary may deem sufficient,

the Under Secretary, or any other staff member designated in writing by the Under Secretary for such purpose, may, on a written application made by such owner to the Under Secretary before the expiry of the applicable period of time for compulsory inspection of motor vehicles specified in the Schedule, or, with the permission of the Under Secretary and on good cause shown, after the expiry of such period of time -

- (aa) in writing extend, in respect of any owner who has made an application for such extension of time, any relevant period of time specified in the Schedule; or
- (bb) request any road transportation inspector or staff member of the Department of Transport, or any police officer or any other person, whether in Namibia or in any other country, to at any time conduct a physical inspection in respect of any motor vehicle as contemplated in section 55B(1) of that Ordinance; or
- (cc) exempt any owner who has made an application for such exemption, from the requirement of having to present his or her motor vehicle at the Data Capture Facility referred to in paragraph (a) for the purpose of inspection, or of having to be present in person at such inspection, or from both such requirements, on the submission of a certificate, issued by -
  - (ab) any road transportation inspector or staff member of the Department of Transport;
  - (ac) any traffic officer or police officer;
  - (ad) any person referred to in subparagraph (bb);
  - (ae) any other person or authority, whether in Namibia or in any other country; or
  - (af) any other staff member,

designated in writing by the Under Secretary for such purpose, which certificate so issued attests to the verification of the relevant particulars contemplated in section 55B(1) of that Ordinance; or

(dd) make such other arrangements, with the approval of the Minister, in order to ensure the achievement of the objects of section 55B of that Ordinance.
