

The Council of the Municipality of Outjo, under section 27(1) of the Local Authorities Act, 1992 (Act 23 of 1992), hereby add the rule to the Personnel Rules promulgated under Government Notice 284 of 1995, as set out in the Schedule:-

RULES OF A MOTOR VEHICLE FINANCE SCHEME FOR SENIOR MUNICIPAL OFFICIALS

As approved by Council. Council Resolution No. 12.5 dated August 28, 2000

1. OBJECTIVE

The objective of this scheme is to provide eligible senior staff officers of the Municipality with allowances which could be used to acquire motor vehicles for official and private use.

2. QUALIFICATION FOR PARTICIPATION IN THE SCHEME

The following officials qualify for the motor scheme:

- a) Town Clerk
- b) Town Treasurer
- c) Head of Department: General services and properties
- d) Head of Department: Workshop
- e) Head of Department: Health, Sewerage and sanitation
- f) Head of Department: Electricity and Water
- g) PRO/Town Secretary

3. LOAN AMOUNTS

- 3.1 That the loan amount be based on the equivalent of the Motor Scheme cars namely:
- a) For the Town Clerk: Toyota Camry 2.2 liter Si
- b) For heads of departments: Volkswagen Jetta CSX 1.6 approved.
- 3.2 That Council will not provide financing out of own funds (capital reserve funds) for purchasing vehicles, but that the official arranges a hire purchase agreement with the bank to finance the purchase of a vehicle of his own choice within the limits of the amount allowed.
- 3.3 The officials are restricted to the amount as approved. If the purchase price exceeds the approved amount, the official will be responsible for the difference to be paid by himself.
- 3.4 The loan shall be repaid in equal monthly instalments of at least 54 months and not more than sixty months.

4. ALLOWANCES

- 4.1 That Council pays a fixed allowance per month to the official to cover expenses.
- 4.2 The allowance payable is liable to the Income Tax Act
- 4.3 The allowance is made up as follows:
- a) The instalment (redemption and interest) payable to the bank.
- b) Yearly licence fee
- c) Yearly insurance (on municipal group insurance)
- d) (i) that a fuel and maintenance allowance, per month, be replace by an amount equal to the cost of 105 litres fuel, for the Town Clerk, Town Treasurer and PRO/Town Secretary.
- d) (ii) the other officials can apply for a fuel allowance based on fuel needed for the job to be done effectively. The officials involved are:
- Head of Department: General services and properties
- Head of Department: Workshop
- Head of Department: Health, sewerage and sanitation
- Head of Department: Electricity and Water

Officials use comprises daily inspections, standby tasks, attending of meetings, work after hours, etc.

e) That in the case of official trips outside the borders of Outjo, the official additionally be compensated the amount equal to the AA tariff for petrol and maintenance only.

5. BUYING CARS

5.1 All cars purchased under this scheme shall be new. Demonstration models or second-hand cars which are not more then two years old from the date of first registration as new, may be bought.

6. INCLUSION OF PRIVATE VEHICLE

A participant who participates in the Scheme for the first time may include his private vehicle in the scheme provided that the vehicle is not more than three years old from the date of first registration as a new vehicle. The terms and conditions of joining shall be determined by the Council.

7. USE OF CARS

- 7.1 Participants in the Scheme are expected to use the vehicle purchased under the Scheme for all official journeys arising from their duties.
- 7.2 There are no restrictions on the use of cars purchased under this scheme for private purposes; provided that the person who drives the vehicle has a valid driver's licence.
- 7.3 A vehicle purchased under this Scheme may not be rented out for a reward.

8. GENERAL

- 8.1 Should any participant abuse, or not adhere to the conditions of the scheme, the Council, may deny such an employee further participation in the scheme.
- 8.2 All the maintenance and running costs are the responsibility of the participant. The municipality shall have the right to inspect the cars in order to ensure that such cars are maintained on a regular basis.
- 8.3 Every official who qualifies for the scheme, will sign the copy of conditions of the scheme for participation.
- 8.4 Every official who qualifies for the scheme, will be treated separately by the Council for the approval.
- 8.5 The scheme is based on the Bank Prime Rate (interest) presently at 15% over 54 months.
