#### ELECTORAL ACT, 1992: BY-ELECTION FOR THE RUNDU URBAN CONSTITUENCY OF THE KAVANGO REGION: PUBLICATION OF CANDIDATES, POLLING DAYS AND POLLING STATIONS

In terms of section 64(5) of the Electoral Act, 1992 (Act No. 24 of 1992), it is hereby made known -

- (a) that a poll shall be taken on 22 December 2000 at 07h00 21h00 for the election of a member of the Regional Council for the Rundu Urban Constituency;
