SITTING OF THE COURT AND VACATIONS

The Judge-President has under section 39(2) of the High Court Act, 1990 (Act No. 16 of 1990), read with rule 2(1) of the Rules of the High Court of Namibia, promulgated under Government Notice No. 59 of 1990, made the rules as set out in the Schedule, which shall come into effect on 1 February 2003.

SCHEDULE

1. For the dispatch of civil business there shall be three terms in each year, as follows:

- (a) From 16 January to 15 April, inclusive;

4. Urgent applications and applications for compulsory sequestration may be heard on any court day.

5. For the dispatch of criminal business, including criminal appeals and reviews, there shall be 2 sessions in the year as follows:

- (a) From 16 January to 31 July, inclusive; and
- (b) from 1 September to 30 November, inclusive."

- 4.2 That Council will not provide financing out of own funds (Capital Reserve Funds) for purchasing vehicles, but that the official arranges a hire purchase agreement with a financial institution of his or her choice, according to the terms agreed to between him or her and the financial institution, to purchase a vehicle within the limits of the amount allowed.
- 4.3 The officials are restricted to the amount allowed as approved. If the purchase price exceeds the approved amount, the official will be responsible for the difference to be paid by him.
- 4.4 The loan shall be repaid in equal monthly installments of at least 54 months and not more than sixty months.

5. Allowances

- 5.1 That Council pays a fixed allowance per month to the official to cover expenses.
- 5.2 The allowance payable is liable to the income Tax Act.
- 5.3 The allowance is made up as follow:
 - i) The instalment (redemption & interest) payable to the bank.
 - ii) Yearly license fee
 - iii) Yearly insurance (on Town Council's group insurance)
- 5.4 That an amount equal to the cost of 80 litres fuel be paid on a monthly basis to the Chief Executive Officer and the Strategic Executives participating in the motor scheme to cover fuel and maintenance.
- 5.5 That in the case of official trips outside the borders of Lüderitz, the official be compensated with an additional amount equal to 50% of the AA tariff for fuel and maintenance only.

6. **Buying Cars**

All cars purchased under this scheme will be new. Demonstration models or secondhand cars which are not more than two years old from the date of first registration as new may be bought.

7. Inclusion of Private Vehicles

A participant who participates in the Scheme for the first time may include his private vehicle in the scheme provided that the vehicle is not more than three years old from the date of first registration as a new vehicle. Council shall determine the terms and conditions of joining.

8. Use of cars

- 8.1 Participants who participate in the scheme are expected to use the vehicle purchased under the scheme for all official journeys arising from their duties.
- 8.2 There are no restrictions on the use of cars purchased under this scheme for private purposes; provided that the person who drives the car has a valid driver's licence.
- 8.3 A vehicle purchased under the scheme may not be rented out for a reward.

9. General

9.1 Should any participant abuse or not adhere to the conditions of the scheme, the Council may deny such an employee further participation in the scheme.

- 9.2 All the maintenance and running costs are the responsibility of the participant. The Town Council will have the right to inspect the cars in order to ensure that such cars are maintained on a regular basis.
- 9.3 Every official who qualifies to participate in the motor scheme will sign the copy of conditions of the scheme before participating.
- 9.4 Every official who qualifies for the scheme will be treated respectively by the Council for the approval.
- 9.5 The scheme is based on the Bank Prime Rate (interest), which is currently 15.75% over 54 months.
- 9.6 The motor vehicle scheme of Lüderitz Town Council will stop after the first cycle of 54 months (4.5 years). During the second cycle of another 54 months (4.5 years) all participating officials will be responsible for any further payments and maintenance, although the fuel allowance will continue as a contribution from Council's side.
- 9.7 After the second cycle the scheme shall start a new, and the participating officials can apply afresh under the same conditions as stipulated in this policy.
