DEVIATION OF A PORTION OF MAIN ROAD 39: DISTRICT OF GOBABIS

It is hereby made known that in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), the Minister has, in the district of Gobabis under section 22(1)(c) of the said Ordinance deviated a portion of main road 39 described in paragraph (a) of the Schedule and shown on sketch-map P2140 by the symbols A-B, from the route so described and shown, to the route described in paragraph (b) of Schedule I and shown on the said sketch-map by the symbols A-C-B.

The said sketch-map shall at all times lie open to inspection at the office of the Roads Authority, Windhoek, during normal office hours.

SCHEDULE

- (a) From a point (A on sketch-map P2140) on the farm Hoaseb 27 generally southwards and more and more south-south-eastwards across the said farm to a point (B on sketch-map P2140) on the said farm.
- (b) From a point (A on sketch-map P2140) on the farm Hoaseb 27 generally southsouth-eastwards across the said farm to a point (C on sketch-map P2140) on the said farm; thence generally southwards and more and more south-south-westwards to a point (B on sketch-map P2140) on the said farm.

PROCLAMATION OF A DISTRICT ROAD (NUMBER 4003): DISTRICT OF USAKOS: ERONGO REGION

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has, in the district of Usakos under section 22(1)(b) of the said Ordinance declared the road described in the Schedule and shown on sketch-map P2143 by the symbols A-B, to be a proclaimed road.
- (b) in terms of section 23(3) of the said Ordinance that the Minister has under section 23(1)(c) of the said Ordinance declared the road referred to in paragraph (a) to be a district road (number 4003).

The said sketch-map shall at all times lie open to inspection at the office of the Roads Authority, Windhoek, during normal office hours.

PROCLAMATION OF A PORTION OF TRUNK ROAD 8/7 AND THE RECLASSIFICATION OF DISTRICT ROAD 3513 TO A PORTION OF TRUNK ROAD 8/7: DISTRICT OF KATIMA MULILO

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has, in the district of Katima Mulilo under section 22(1)(b) of the said Ordinance declared the road described in Schedule I and shown on sketchmap P2144 by the symbols A-B to be a portion of a proclaimed road.
- (b) in terms of section 23(3) of the said Ordinance that the Minister has -
 - (i) under section 23(1)(b) of the said Ordinance declared the road referred to in paragraph (a) to be a portion of trunk road (number 8/7).

 (ii) under section 23(1)(e) of the said Ordinance amended the classification of district road 3513 described in Schedule II and shown on sketch-map P2144 by the symbols B-C-D-E to a portion of trunk road 8/7.

The said sketch-map shall at all times lie open to inspection at the office of the Roads Authority, Windhoek, during normal office hours.

From a point (A on sketch-map P2144) on the international border of Zambia and Namibia generally south-south-eastwards to a point (B on sketch-map P2144) at the place known as Wenela.

SCHEDULE II

From a point (B on sketch-map P2041) at the place known as Wenela generally southwards to a point (C on sketch-map P2144); thence generally south-south-eastwards to a point (D on sketch-map P2144); thence generally south-eastwards and more and more eastwards to a point (E on sketch-map P2144) at the junction with trunk road 8/5 at the place known as Katima Mulilo.
