GENERAL ELECTION FOR ELECTION OF THE PRESIDENT: NOTIFICATION OF DAY AND PLACE FOR SUBMISSION OF NOMINATIONS OF CANDIDATES FOR ELECTION AND POLLING DAYS

In respect of the general election for the election of the President pursuant to Article 28 of the Namibian Constitution, read with section 49(1)(a)(i) of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known, under the powers vested in me by section 50(1)(a) and (b) of that Act, that I have determined -

- (a) Friday, 8 October 2004, as the date on which the submission of nominations of candidates for election as President shall take place at a public sitting to be held by the Chairperson of the Electoral Commission at the High Court, Windhoek in terms of sections 55(1) and 56 of the Electoral Act, 1992; and
- (b) Monday, 15 November 2004, and Tuesday, 16 November 2004, as the days on which a poll shall be taken at the election of the President.

GENERAL ELECTION FOR ELECTION OF MEMBERS OF THE NATIONAL ASSEMBLY: NOTIFICATION OF LAST DAY AND PLACE FOR SUBMISSION OF LISTS OF NOMINATED CANDIDATES BY POLITICAL PARTIES AND POLLING DAYS

In respect of the general election for the election of members of the National Assembly pursuant to Article 46 of the Namibian Constitution, read with section 49(1)(b)(i) of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known, under the powers vested in me by section 50(1)(a) and (b) of that Act, that I have determined -

- (a) Friday, 8 October 2004, as the last day on which political parties that intend to participate in the election for members of the National Assembly shall, not later than 11h00 on that day, submit a list of their nominated candidates in terms of section 59(1) of the Electoral Act, 1992, to the Electoral Commission at the office of the Director of Elections, Directorate of Elections, 12 Daniel Munamava Street, Windhoek; and
- (b) Monday, 15 November 2004, and Tuesday, 16 November 2004, as the days on which a poll shall be taken at the election of members of the National Assembly.

GENERAL ELECTION FOR ELECTION OF THE PRESIDENT AND MEMBERS OF THE NATIONAL ASSEMBLY: NOTIFICATION OF APPOINTMENT OF RETURNING OFFICERS

Under the powers vested in me by section 50(1)(c) of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known that -
