

- 1. A REPRODUCTION OF THE NAME, ABBREVIATION AND EMBLEM OF THE INTERNATIONAL INSTITUTE FOR THE UNIFICATION OF PRIVATE LAW (UNIDROIT); (Schedule 1)
- 2. A REPRODUCTION OF THE EMBLEM OF THE REGISTRAR OF COMPANIES AND OFFICIAL RECEIVER, INTELLECTUAL AND INDUSTRIAL PROPERTY SECTION (OFFICIAL SIGN INDICATING CONTROL AND WARRANTY OF THE REPUBLIC OF CYPRUS); (Schedule 2);

The State flags, State emblems, coats of arms and other marks, and the other flags and emblems, in question shall be open to inspection at the office of the Permanent Secretary: Trade and Industry, Second Floor, Block B, Brendan Simbwaye Square, Corner of Goethe and Uhland Street, Windhoek.


