DECLARATION OF HIS EXCELLENCY, PROF. P. KATJIVIVI, AND HER EXCELLENCY, C.G. UUSHONA, AS OFFICE-BEARERS: MEMBERS OF PARLIAMENT AND OTHER OFFICE-BEARERS PENSION FUND ACT, 1999 (ACT NO. 20 OF 1999)

Under the powers vested in me by section 1(2) of the Members of Parliament and other Office-bearers Pension Fund Act, 1999 (Act No. 20 of 1999), I declare, with effect from 15 October 2003 -

(a) His Excellency, Prof. P. Katjivivi, who holds the office of Ambassador of the Republic of Namibia to Belgium and the European Union; and

(b) Her Excellency, C.G. Uushona, who holds the office of Ambassador of the Republic of Namibia to Cuba,

as office-bearers for purposes of the rules of the Members of Parliament and other Office-bearers Pension Fund established by section 2 of that Act.
