AMENDMENT TO ROAD TRAFFIC AND TRANSPORT REGULATIONS: ROAD TRAFFIC AND TRANSPORT ACT, 1999

The Minister of Works, Transport and Communication has under section 91 of the Road Traffic and Transport Act, 1999 (Act No. 22 of 1999), -

- (a) made the regulations set out in the Schedule; and
- (b) withdrawn the regulations promulgated under Government Notice No. 206 of 28 September 2004.

SCHEDULE

1. In these regulations, "the Regulations" means the Road Traffic and Transport Regulations promulgated under Government Notice No. 53 of 30 March 2001, as amended by Government Notice No. 97 of 29 May 2001, No. 103 of 01 July 2002, No. 161 of 26 September 2002, No. 163 of 26 September 2002, No. 205 of 28 September 2004 and No. 32 of 1 April 2005.

Amendment of regulation 1 of the Regulations

2. Regulation 1 of the Regulations is amended by the deletion of the definition of "issuing authority";".

Amendment of regulation 29 of the Regulations

- 3. Regulation 29 of the Regulations is amended -
- (a) by the substitution for paragraph (h) of the following paragraph:
 - "(h) on which a specific licence number is issued in terms of regulation 36;"; and
- (b) by the addition of the following paragraphs:
 - "(i) on which a licence number of motor vehicle is transferred in terms of regulation 36A; and
 - (j) determined by the Minister in any circumstances not contemplated in this regulation.".

Amendment of regulation 31 of the Regulations

4. Regulation 31 of the Regulations is amended by the deletion of paragraph (h).

Substitution of regulation 36 of the Regulations

5. The following regulation is substituted for Regulation 36 of the Regulations:

"Specific licence numbers

36. (1) For the purpose of this Part, a "specific licence number" means -

- (a) a licence number reserved by the Minister in terms of subregulation (2); or
- (b) a licence number requested for in terms of subregulation (3)(b).

(2) The Minister may, as he or she may consider necessary reserve, as specific licence numbers, the licence numbers referred to in regulation 34(1) and (2), for the purpose of allocation to any person who requests for such number in terms of subregulation (3).

(3) A person may, on an approved form and on the payment of the fee prescribed in Schedule 1, request the appropriate registering authority to allocate -

- (a) a specific licence number reserved in terms of subregulation (2); or
- (b) any other specific licence number of such person's choice,

to a motor vehicle of which such person is the owner.

(4) On receipt of a request made in terms of subregulation (3), the registering authority must, if satisfied that the specific licence number requested for in terms of that subregulation has not been allocated to another motor vehicle, allocate such licence number to the motor vehicle which is owned by the person referred to in that subregulation.".

Insertion of regulation 36A

6. The following regulation is inserted after Regulation 36 of the regulations:

"Transfer of a licence number

"36A (1) An owner of a motor vehicle may apply to an appropriate registering authority for the transfer of a licence number allocated to a motor vehicle -

- (a) from a motor vehicle of which the applicant is an owner to another motor vehicle of which the applicant is the owner; or
- (b) from the motor vehicle of one owner to a motor vehicle owned by another person.

(2) The application referred to in subregulation (1) must be accompanied by the fee prescribed in Schedule 1.

(3) On receipt of an application made in terms of subregulation (1), the registering authority may transfer the relevant number to the respective motor vehicle referred to in the application.".
