### PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBL-IC OF NAMIBIA

3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.
