The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

#### **APPROPRIATION AMENDMENT ACT, 2015**

### **ACT**

To amend the Appropriation Act, 2015, so as to increase and decrease certain amounts of money in the Schedule to that Act to meet the financial requirements of the State during the remainder of the financial year ending 31 March 2016.

(Signed by the President on 26 November 2015)

**BE IT ENACTED** as passed by the Parliament, and assented to by the President, of the Republic of Namibia as follows:

#### Substitution of Schedule to Act No. 4 of 2015

1. The Appropriation Act, 2015 is amended by the substitution of the following Schedule for the Schedule to that Act.

#### **Short title**

2. This Act is called the Appropriation Amendment Act, 2015.
