NOTICE IN TERMS OF THE REGULATIONS REGARDING LICENSING PROCEDURES FOR TELECOMMUNICATIONS AND BROADCASTING SERVICE LICENCES AND SPECTRUM USE LICENCES

The Communications Regulatory Authority of Namibia, in terms of Regulation 11(1) of the "Regulations Regarding Licensing Procedures for Telecommunications and Broadcasting Service Licences and Spectrum Use Licences", in Government Gazette No. 4785, General Notice No. 272, dated 29 August 2011 (as amended), herewith gives notice that **Mobile Telecommunications Limited** has submitted applications for the transfer of the indirect control of its Telecommunications Service Licence and Spectrum Use Licence as follows:

Samba Luxco S.A.R.L has agreed to sell and transfer Samba DutchCo B.V (100% shares) to NPTH, which transaction will result in NPTH indirectly acquiring the 34% shares in MTC.

The public may submit comments in writing (in respect of both applications) to the Authority within a period of fourteen (14) days from the date of publication of this notice in the *Gazette*. The applicant may submit written reply comments within fourteen (14) days from date of notification of the written public comments.
