Under the powers vested in me by section 64(1) of the Electoral Act, 2014 (Act No. 5 of 2014) read with section 80 of that Act, I, upon the recommendation of the Electoral Commission of Namibia, make known that in respect of the by-election for a member of the Kunene Regional Council, Opuwo Rural Constituency in the Kunene Region, I determine -

(a) 21 May 2021 as the date upon which submissions of nominations of candidates for the election of a member of the Kunene Regional Council, Opuwo Rural Constituency, Kunene Region, must take place;
