(d) evidence of payment of Personal Income tax in the case of un-incorporated businesses or company tax in the case of incorporated businesses for the immediately preceeding 3 years and excise duty as applicable for the past 3 years.

In addition to the above documentary evidence, applicants are enjoined to request their bankers to send directly to the office of the Import Licensing Authority a report on their credit worthiness and main line of business.

3. Applicants are reminded to indicate the amount they require for each specific item for which they are applying. Value of each item should be expressed in NAIRA only. The business or registered address of the applicant should be stated. Post office Box or Private Mail Bag number *will not* be accepted.

4. Applicants resident outside Lagos are requested to obtain APPLICATION FORMS from the Trade Offices of the Federal Ministry of Trade located in their respective states and to submit the completed forms to the said offices.

5. The closing date for the submission of application forms is 31st May, 1979. However, applications for industrial raw materials will continue to be entertained beyond this date.

Applications are invited from suitably qualified candidates for the following posts in the College of Medicine of the University of Lagos:

Qualifications :

(a) **Chief Accountant.**—Membership of a recognised professional Accounting body, i.e. A.C.A., A.C.C.A., A.C.M.A., or I.P.F.A. with not less than five years' post-qualification experience.

(b) **Accountant, Grade I.**—Membership of a recognised professional Accounting body, i.e. A.C.A., A.C.C.A., A.C.M.A. or I.P.F.A. with one year post-qualification experience or B.Sc. honours Accountancy or C.I.S. with not less than two years' post-qualification experience.

(c) **Higher Technical Officer (Transport).**—Ordinary National Diploma in Automobile Engineering or Final Certificate of the Institute of Motor Industry or Equivalent plus a minimum of three years' post-qualification experience. Certificate in Transport Administration will be an added advantage.

(d) **Trainee Glass-Blowers.**—West African School Certificate with passes in any two Science Subjects. A pass in Mathematics will be an added advantage.

Duties :

(a) **Chief Accountant.**—The successful candidate will be responsible for—

- (i) Budgetary and Expenditure Control ;
- (ii) Final Accounts preparation ;

- (iii) Foreign Exchange transaction ; and
- (iv) Capital Projects.

(b) *Accountant, Grade I.*—The successful candidate will be responsible for the supervision of normal Accounting work with particular reference to Cash Office, Salary preparation, Debtors, and Creditors' ledgers and carry out any other duties as assigned by the Assistant Bursar.

(c) *Higher Technical Officer (Transport).*—The successful candidate will be responsible for the supervision of drivers and controlling a fleet of College vehicles. He would also be responsible for the day-to-day administration of the transport section and perform such other duties as may be directed.

(d) *Trainee Glass-Blowers.*—Successful candidates will receive formal training at the College of Medicine of the University of Lagos and at the University of Ibadan where a course in Glass-Blowing has been initiated by that University and the British Society of Glass-Blowers. The career offers opportunities for advancement to the highest possible grade in the Technical Field.

Conditions of Service.—For posts (a), (b) and (c)—Appointment which is either on a permanent or contract basis will commence as soon as possible. Non-contract appointees will be on probation for the first two years and will be considered for confirmation to retirement age thereafter if their services are considered satisfactory. Car and leave transport grant. Pension scheme and partly furnished accommodation at rentals not exceeding 8½ per cent of salary or rent allowance of between ₦480 and ₦720 per annum in lieu. Contract appointees will be entitled to contract addition on their basic salary payable monthly with salary and contract gratuity payable at the end of each tour.
