FEDERAL MINISTRY OF TRADE

ITEMS OF IMPORT UNDER SPECIFIC IMPORT LICENCE

The attention of the public in general and all importers in particular is drawn to Legal Notice No. 10 of 1979—Import Prohibition Order 1979—published in the Federal Gazette Extraordinary No. 16 of 1st April, 1979 Volume 66 which places the undermentioned items of import under specific import licence :-

- (i) Unmanufactured tobacco, tobacco refuse (Tariff No. 24.01);
- (ii) Other manufactured tobacco (Tariff No. 24.02);
- (iii) Packaging containers excluding those made of a glass (Tariff No. 24.16);
 - (iv) Stockfish (Tariff No. 03.02A);
- (v) Manufactured articles of wood of all types whether or not for domestic or decorative use (Tariff Nos. 44.19-44.28) excluding flush doors, match splints and skillets;
