In Exercise of the powers conferred by Section 28 (I) of the Obas and Chiefs of Law. Cap 02. Laws of Lagos State of Nigeria. 2003 and all other powers enabling him in that behalf, the Governor of Lagos State by this Notice hereby.

1. Declares his intention to create after the expiration of thirty (30) days from the publication of this Notice, the underlisted Chieftaincy title in Ibeju Lekki Local Government Area.
