THE LAND USE ACT (CAP. L5 OF 2004) LAND USE REGULATIONS 1981 LAWS OF FEDERATION OF NIGERIA

NOTICE OF REVOCATION OF RIGHT OF OCCUPANCY WITH CERTIFICATE OF OCCUPANCY NUMBER 61/61/2008N ISSUED TO SPARICON ASSOCIATES LIMITED

In the matter of all that parcel of vacant undeveloped land situated at and referred to as Plot 19E (1) Victoria Island Annex Victoria Island in Eti-Osa Local Government Area of Lagos State of Nigeria.

- 1. WHEREAS, the Governor of Lagos State of Nigeria requires all that parcels of land specified in the Schedule to this Notice as a result of Sections 10 (b) and 28 of the Land Use Act Cap. L5 Laws of the Federation of Nigeria 2004 and fundemental terms and conditions contained in the Certificate of Occupancy (failure to develop the land within two years. - 3. NOW THEREFORE, in exercise of the powers conferred on me pursuant to Section 28 of the Land Use Act, I, AKINWUNMI AMBODE, the Governor of Lagos State hereby revoke the existing right of occupancy in the said land with effect from the date of this Notice for the reasons given above.
- 4. That I or any person duly authorized by the Governor in that behalf shall take possession of the said parcel of land and that any owner or occupier of the said land or any part of it is accordingly directed to yield up possession of the land.
- 5. Any person who shall willfully hinder or obstruct the Governor or any person authorized by him from taking possession of the said land or any part thereof or from the execution of any function under the provision of the Land Use Act Cap. L5 of 2004 Laws of The Federation of Nigeria shall be dealt with according to Law.
- 6. Compensation shall be payable on Revocation of Right of Occupancy in appropriate and special cases in accordance with the provisions of the said Act.
