# NOTICE OF INTENTION TO CREATE A RECOGNIZED CHIEFTAINCY TITLE (KOSOFE LOCAL GOVERNMENT AREA) 2016.

#### Commencement: (22th January, 2015)

In exercise of the powers conferred by Section 28 (i) of the Obas and Chiefs of Lagos State Law, Cap. 02, Laws of Lagos State of Nigeria, 2003 and of all other powers enabling him in that behalf, the Governor of Lagos State by this Notice hereby declares his intention to create after the expiration of thirty (30) days from the publication of this Notice, the underlisted recognised Chieftaincy Title in Kosofe Local government Area:
