In Exercise of the powers conferred by Section 22 of the Obas and Chiefs of Law, Cap 02, Laws of Lagos State of Nigeria, 2003 and all other powers enabling him in that behalf, the State Executive Council at its 38th meeting held on 31st August, 2016 approved the white paper on the Supreme Court judgement that Amended the Ojora Chieftaincy family as the owner of Igamu Land in the Supreme Court of Nigeria Holden at Abuja on Friday 3rd day of April, 2009, in Apapa Local Government Area of Lagos State.
