WITHDRAWAL OF REVOCATION OF RIGHTS OF OCCUPANCY

in the matter of all the parcel of land situate, lying and being at Parkview residential Scheme, lkoyi, the Blocks and plots as well as the detailed registration particulars are well described in the schedule below which plots were affected by the Notice of Revocation dated 31st August, 2016 served on all the holders of statutory rights of Occupancy as contained in the Notice.

2. WHEREAS: (i)

- By virtue of Notice of Revocation dated 31st August 2016, the Rights of Occupancy in respect of Blocks and Plots contained in the said Natice were revoked on the ground of failure to develop the plots within two years, failure to pay the ground rent and breach of fundamental terms and conditions stated in the Certificates of Occupancy.
