# LAND USE ACT CAP L5 LAW OF THE FEDERATION OF NIGERIA, 2004 NOTICE OF REVOCATION OF RIGHT OF OCCUPANCY

In the matter of all that parcel of land (with any improvement thereon) situate, lying and being along Ogunnusi Road, Ojodu in Ojodu Local Council Development Area of Lagos State of Nigeria.

2. Whereas the Governor of Lagos State of Nigeria requires for overriding public interest (Construction of Bus Terminus) all that parcel of land along Ogunnusi Road (Ojodu Main Market) at Ojodu in Ojodu Local Council Development Area of Lagos State of Nigeria containing an approximate area of 1.880 hectares covered by the judgment in suit No. 1D/1098/2000 dated 21st November, 2003 and registered as No. 50/50/2498 at the Lagos State of Nigeria Land Registry, the boundaries of which are described in the schedule hereto and more particularly delineated in the plan at the office of the Director of Land Services, Lands Bureau, Governor's Office, the Secretariat, Alausa-Ikeja.

# GOVERNOR'S OFFICE LANDS BUREAU

- 3. NOW THEREFORE, in the exercise of the powers conferred on me pursuant to Section 28 of the Land Use Act, I AKINWUNMI AMBODE, the Governor of Lagos State hereby give this notice to the holder revoking the existing right of occupancy in the said land with effect from the date of service of this notice for the reason given above.
- 4. Any holder, owner or occupier of the said land or any part thereof is accordingly directed to yield up possession of the land on or before the expiration of the period specified in this Notice.
- 5. Any person claiming to have any right or interest in the said land is required within twenty-one (21) days from the date of this Notice to send to the Permanent Secretary, Lands Bureau, Governor's Office, The Secretariat, Alausa Ikeja, Lagos State of Nigeria, a statement of his interest and evidence of any claim made in respect of such interest.
- 6. Any such statement shall be made by the said Claimant in person or through an agent (duly authorized by the Claimant in that behalf) having qualifications, which are not less than those of Legal Practitioner, Estate or Valuation Officer employed in any Public Services of the State or Federation.
- Any claim to any estate, interest or right in respect of any improvements on the said land affected by the Notice shall not be entertained after the expiration of twelve (12)

months from the date of the publication of this Notice in the Lagos State Government Official Gazette.

- 8. Any person who shall willfuly hinder or obstruct the Governor or any person authorized by him from taking possession of the said land or any part thereof or from the execution of any function under the provision of the Land Use Act Cap. L5 Law of the Federation of Nigeria shall be dealt with according to Law.
- Compensation shall be payable on revocation of right of occupancy in appropriate and special cases in accordance with the provision of the said Act.
