THE LAND USE ACT (CAP L5) LAWS OF THE FEDERATION OF NIGERIA, 2004 NOTICE OF REVOCATION OF RIGHT OF OCCUPANCY

TO:

UTHMAN MUSTAPHA STREET, EPE, LAGOS STATE.

In the matter of all that parcel of land (with any improvement thereon) situate and lying at Uthman Mustapha Street, Oloja Estate Epe, Epe Local Government Area:

1. Whereas the Government of Lagos State of Nigeria requires all that land specified in the Schedule to this Notice for overriding public interest for Right of Way (Rehabilitation and Upgrading of Strategic Arterial/Inner Roads in Epe) more particularly delineated in the plan at the Office of the Director of Lands Services, Lands Bureau, Governor's Office, the Secretariat, Obafemi Awolowo Way Ikeja.

2. NOW THEREFORE, in the exercise of the powers conferred on me pursuant to Section 28 of the Land Use Act, Cap.
