AND WHEREAS it appears to the Lagos Town Council (hereinafter referred to as the Council), in the exercise of the functions conferred upon the local authority under section 53 of the Townships Ordinance, that the whole of Henrietta Street in the town of Lagos is unnecessary:

AND WHEREAS the Council have complied with the provisions of section 53 of the Townships Ordinance:

AND WHEREAS a report from the Council has been laid before and considered by the Governor-General in Council;

Now, THEREFORE in exercise of the powers conferred by section 55 of the Townships Ordinance, the Governor-General, after consultation with the Council of Ministers, has made the following order—

- 1. This Order may be cited as the Henrietta Street, Lagos (Closure) Order, 1958.
- Citation.
- 2. The whole of Henrietta Street shall be closed unconditionally on the grounds that it is unnecessary.

- This Order may be cited as the George Street, Lagos (Closure) Order, 1958.
- The whole of George Street which extends for one hundred and forty feet from its junction with Alapafuja Street shall be closed unconditionally on the grounds that it is unnecessary.

IMMIGRATION ORDINANCE (CHAPTER 89)

Victor Penzella—Deportation Order

Commencement: 2nd September, 1958

WHEREAS on the 28th day of July, 1958, before the Magistrate's Court of the Lagos Magisterial District VICTOR PENZELLA was charged with entering into Nigeria being a prohibited immigrant contrary to the Immigration Ordinance and was convicted under section 14 (1) of the said Ordinance, as amended by the Immigration (Amendment) Ordinance, 1956;

AND WHEREAS the Governor-General has considered the facts of the case and deemed it fit to make a deportation order;

Now, THEREFORE, in exercise of the powers conferred by section 14 (1) of the Immigration Ordinance, as amended by the Immigration (Amendment) Ordinance, 1956, the Governor-General hereby makes a deportation order requiring the said VICTOR FENZELLA, upon the expiration of any sentence of imprisonment which he is now serving, or as soon as arrangements have been made for his earlier deportation, to leave and remain out of Nigeria.
