# PUBLIC ORDER (LAGOS) ORDINANCE, 1955 (No. 16 of 1955)

Public Order (Lagos) Order, 1959

Commencement: 1st January, 1959

Whereas it has come to the notice of the Minister of Lagos Affairs, Mines and Power (hereinafter referred to as the Minister) that certain persons intend to organise a ceremony purporting to be for the crowning of one Oluye Docemo as King Docemo II of Lagos and to hold public meetings and public processions in Lagos in connection therewith within a period of three months from the commencement of this order:

AND WHEREAS the Minister is of opinion that, by reason of particular circumstances existing in Lagos, the powers conferred upon the Minister by subjection (1) of section 5 of the Public Order (Lagos) Ordinance, 1955 (as adapted by the Lagos (Transfer of Powers and Duties) Order, 1958) will not be sufficient to prevent serious public disorder being occasioned by the holding of the said intended public meetings and public processions in Lagos:

Now THEREFORE in exercise of the powers conferred by subsection (2) of section 5 of the Public Order (Lagos) Ordinance, 1955 (as adapted by the Adaptation of Laws Order, 1957) the Minister of Lagos Affairs, Mines and Power has made the following order—

1. This order may be cited as the Public Order (Lagos) Order, 1959.

Citation.

2. All public meetings and public processions in connection with any ceremony or intended ceremony purporting to be for the crowning of one Oluyé Docemo as King Docemo II of Lagos or which may reasonably be regarded as in connection with such ceremony or intended ceremony are hereby prohibited in Lagos for a period of three months from the coming into operation of this order.

# FUNCTIONS OF RESIDENTS (EASTERN REGION) ORDINANCE, 1956 (No. 33 or 1956)

#### Functions of Residents (Eastern Region) Order, 1959

Commencement: 1st January, 1959

In exercise of the powers conferred upon the Governor-General by section 5 of the Functions of Residents (Eastern Region) Ordinance, 1956, and after consultation with the Council of Ministers except so far as concerns the use and operational control of the police, the following order is hereby made with the consent of the Governor of the Eastern Region—

Citation and commencement.

- 1. This order may be cited as the Functions of Residents (Eastern Region) Order, 1959, and shall come into operation on the 1st day of January, 1959.
- 2. In this order, the expression "the Regional Minister of Agriculture, of Commerce, of Health, of Internal Affairs and of Welfare" means in each case the Regional Minister of the Eastern Region charged with responsibility for such respective matters by whatever title he may from time to time be called.

Authority conferred. Schedule.

3. The officers or authorities of the Eastern Region named in the third column of the Schedule are authorised to discharge in the Eastern Region the functions set out in the first column which are conferred on Residents by the Ordinances and sections thereof named in the second column.

Elections (House of Representatives) (Amendment No. 3)

#### Regulations, 1958

Commencement : 27th November, 1958

In exercise of the powers conferred by autition 5 of the Nigeria (Electoral Provisions) Order in Council, 1958, the Governor-General, after consultation with the Council of Ministers, has made the following regulations---

1. These regulations may be cited as the Elections (House of Representatives) (Amendment No. 3) Regulations, 1958, and shall be deemed to have come into operation on the 27th of November, 1958.

2. The First Schedule to the Elections (House of Representatives) Regulations, 1958, as amended by the Elections (House of Representatives) (Amendment No. 2) Regulations, 1958, is amended by the deletion of rule 1 and rule 1A therein, and by the substitution therefor of the following—

"I. The place of ordinary residence of a person is that place where he usually lives, or which has always or generally been his home, or which is the place to which he intends to return when away therefrom."
