**NIGERIAN BROADCASTING CORPORATION  
ORDINANCE, 1956 (No. 39 of 1956)**

**(Vesting of Additional Assets) Order, 1959**

*Commencement : 12th March, 1959*

In exercise of the powers conferred by section 39 of the Nigerian Broadcasting Corporation Ordinance, 1956, the Governor-General, after consultation with the Council of Ministers, has made the following Order—

1. This order may be cited as the (Vesting of Additional Assets) Order, 1959. Citation.

2. The assets specified in the Schedule shall be added to the assets described in the Third Schedule to the Nigerian Broadcasting Corporation Ordinance, 1956.
