NIGERIA (CONSTITUTION) ORDER IN COUNCIL, 1960

Director of Public Prosecutions of the Federation (Exercise of Powers in Regions) Notice, 1960

Commencement: 22nd December, 1960

In exercise of the powers conferred by section 97 of the Constitution of the Federation, of the Director of Public Prosecutions of the Federation has conferred a general authority as follows—

- 1. (1) This notice may be cited as the Director of Public Prosecutions of the Federation (Exercise of Powers in Regions) Notice, 1960.
 - (2) This authority is granted with effect from the 22nd December, 1960.
- 2. Subject to such conditions and exceptions as may be communicated in writing by the Director of Public Prosecutions of the Federation from time to time, the Directors of Public Prosecutions of Northern Nigeria, Western Nigeria and Eastern Nigeria are hereby generally authorised to exercise the powers conferred by paragraphs (a), (b), and (c) of subsection (2) of section 97 of the Constitution of the Federation in relation to prosecutions before the courts of their respective Regions.

This notice authorises the Director of Public Prosecutions of Northern, Western, and Eastern Nigeria to exercise the powers of the Director of Public Prosecutions of the Federation.

PUBLIC ORDER (LAGOS) ORDINANCE (CHAPTER 169)

Public Order (Lagos) Order, 1960

Commencement: 22nd December, 1960

Whereas the Minister of Lagos Affairs is of opinion that, by reason of particular circumstances existing in Lagos, the powers conferred upon the Minister by subsection (1) of section 5 of the Public Order (Lagos) Ordinance will not be sufficient to prevent serious public disorder being occasioned by the holding of public meetings or public processions in Lagos during the period of two weeks following the 22nd December, 1960:

Now therefore, in exercise of the powers conferred by subsection (2) of section 5 of the Public Order (Lagos) Ordinance the Minister of Lagos Affairs has made the following Order

1. This Order may be cited as the Public Order (Lagos) Order, 1969.

Citation.

Prohibition of public meetings and processions in Lagos. 2. All public meetings and public processions are hereby prohibited in Lagos for a period of two weeks from the 22nd December, 1960, that is to say, from the 22nd December, 1960, to the 4th January, 1961, inclusive.

PUBLIC ORDER (LAGOS) ORDINANCE (CHAPTER 169)
Notification of Public Meetings and Processions Order, 1960

Commencement: 5th January, 1961

In exercise of the powers conferred by subsection (1) of section 4 of the Public Order (Lagos) Ordinance, the Minister of Lagos Affairs has made the following Order—

Citation and commencement. 1. This Order may be cited as the Notification of Public Meetings and Processions (No. 2) Order, 1960, and shall come into force on the 5th January, 1961.

Notification of public meetings and processions.

2. It is hereby ordered that not less than 24 hours notice in writing shall be given to the Deputy Commissioner of Police, Lagos Police Area, or in his absence the Assistant Commissioner of Police, Headquarters, Lagos Police Area, of every public meeting or public procession which is intended to be held in Lagos.
