Cocoa (Inspection for Export) (Amendment) Regulations, 1960

In exercise of the powers conferred by subsections (1) and (3) of section 7 of the Produce (Enforcement of Export Standards) Ordinance, 1959, the Federal Minister of Commerce and Industry has made the following Regulations :—

1. (1) These regulations may be cited as the Cocoa (Inspection for Export) (Amendment) Regulations, 1960.

Citation and application.

(2) These regulations shall apply in respect of the Federal Territory of Lagos and also at any port of shipment of produce for export from Nigeria.

2. Regulation 3 of the Cocoa (Inspection for Export) Regulations, 1951, (as amended by the Cocoa (Inspection for Export) (Amendment) Regulations, 1955) is amended by deleting—
