Her Majesty, by virtue and in exercise of the powers in that behalf by the Foreign Jurisdiction Act, 1890(a), or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Nigeria (Offices of Governor-General and Governors) (Amendment) Order in Council, 1960, and shall be construed as one with the Nigeria (Offices of Governor-General and Governors) Orders in Council, 1954 to 1959(b).

Citation, construction and commencement.

- (2) The Nigeria (Offices of Governor-General and Governors) Orders in Council, 1954 to 1959, and this Order may be cited together as the Nigeria (Offices of Governor-General and Governors) Orders in Council, 1954 to 1960.
 - (3) This Order shall come into operation on the 15th day of April, 1960.
- 2. LAGOS TOWN PLANNING ORDINANCE (CHAPTER 103)

The Apapa Town Planning Scheme, 1947 (Amendment)
Order, 1960

Commencement: 5th May, 1960

In exercise of the powers conferred by section 24A of the Lagos Town Planning Ordinance, the Lagos Executive Development Board, with the approval of the Minister of Lagos Affairs, has made the following Order—

1. This Order may be cited as the Apapa Town Planning Scheme, 1947 (Amendment) Order, 1960, and shall be of application in the Federal Territory of Lagos.

2. Clause I of the Apapa Town Planning Scheme, 1947 (as approved by the Apapa Town Planning Scheme, 1947 (Approval) Order, 1948) is hereby amended by deleting the third paragraph thereof (the definition of "the Plan") and substituting therefor the following—

"The Plan" means the plan No. LTP.709 prepared in duplicate on the instruction of the Lagos Executive Development Board (the original and duplicate sealed with the Official of the Board and marked "Plan referred to in the Apapa Town Planning Scheme" and signed by the Chairman of the Board) of which the original is deposited at the Office of the Board and the duplicate at the Office of the Town Clerk to the Lagos Town Council; and amendment plan No. LTP.1270 (in duplicate) affixed to the original and duplicate of the Plan No. LTP.709 aforesaid".
