# WEIGHTS AND MEASURES ORDINANCE (CHAPTER 228)

## Weights and Measures (Fees) Regulations, 1960

Commencement: 1st October, 1960

In exercise of the powers conferred by section 45 of the Weights and Measures Ordinance, the Governor-General, after consultation with the Council of Ministers, has made the following regulations—

- 1. These regulations may be cited as the Weights and Measures (Fees) Regulations, 1960, and shall be of Federal application.

## THE MINERALS ORDINANCE (CHAPTER 134)

The Prospecting (Areas and Minerals) Prohibition (Amendment)
Declaration, 1960

Commencement: 18th August, 1960

In exercise of the powers conferred by section 8 of the Minerals Ordinance, the Minister has made the following declaration:—

- 1. This declaration may be cited as the Prospecting (Areas and Minerals) Prohibition (Amendment) Declaration, 1960.
- 2. The Prospecting (Areas and Minerals) Prohibition Declaration, 1946, is hereby amended as follows:—

for sub-paragraph 1 (b) of paragraph 2, substitute:

"(b) (i) All that piece of land known as Naraguta Government Station, situated on the North-East of Jos Town in the Gwong District of Jos Division, Plateau Province, consisting of 6,743 square miles, exclusive of certificate of Occupancy 1496 the boundaries of which are delineated by verged lines, are more particularly described as follows:—

Starting from Property Beacon 872 whose distance from Triangulation Station N.I is 843 feet on a bearing of 257° 44' the boundary runs for a distance of
