The Queen's Most Excellent Majesty in Council.

Her Majesty, by virtue and in exercise of the powers in that behalf by the Foreign Jurisdiction Act, 1890(a), or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Nigeria (Constitution) (Amendment No. 2) Order in Council, 1960, and shall be construed as one with the Nigeria (Constitution) Orders in Council, 1954 to 1959(b), and the Nigeria (Constitution) (Amendment) Order in Council, 1960(c).

(2) The Nigeria (Constitution) Orders in Council, 1954 to 1959, the Nigeria (Constitution) (Amendment) Order in Council, 1960, and this Order may be cited together as the Nigeria (Constitution) Orders in Council, 1954 to 1960.

(3) Section 1 of the Nigeria (Constitution) (Amendment) Order in Council, 1960, is amended by the deletion of subsection (2).

(4) This Order shall come into operation on the fifth day of August, 1960.

2.—(1) Section 21 of the Nigeria (Constitution) Order in Council, 1954(d) (as amended by section 7 of the Nigeria (Constitution) (Amendment No. 2) Order in Council, 1957(e), section 9 of the Nigeria (Constitution) (Amendment) Order in Council, 1958(f), and section 5 of the Nigeria (Constitution) (Amendment) Order in Council, 1959(g)) is amended by the deletion from subsection (1) of the words "one hundred and seventy-four" in paragraph (b) and the substitution of the words "one hundred and sixty-seven".

3. Section 26 of the Nigeria (Constitution) Order in Council, 1954, is amended by the deletion from subsection (2) of the word "fifty" and the substitution of the words "one hundred and twenty-four".

4.—(1) Section 36B of the Nigeria (Constitution) Order in Council, 1954 (as set out in subsection (1) of section 22 of the Nigeria (Constitution) (Amendment No. 3) Order in Council, 1959(a)) is amended—

(a) by the deletion from subsection (1) of the words "one hundred and seventy-four" and the substitution of the words "one hundred and sixty-seven"; and

(b) by the addition to subsection (1) of the following proviso:—

"Provided that no electoral districts shall be established in those parts of the Cameroons that are comprised in the Region."

(2) This section shall come into operation on the date on which section 2 of this Order comes into operation.

NOW, THEREFORE, under section 7 (b) of the Aliens (Deportation) Ordinance, it is hereby ordered that the said ANDREAS SONWA shall leave Nigeria on the first available opportunity and remain thereafter out of Nigeria.



WHEREAS it is provided by subsection (2) of section I of the Federal Supreme Court Ordinance, 1960, that the said Ordinance shall not come into operation unless and until the Governor-General notifies by Proclamation that it is Her Majesty's pleasure not to disallow the same and that thereafter the said Ordinance shall come into operation upon such day as the Governor-General shall notify by the same or any other Proclamation:

AND WHEREAS Her Majesty's pleasure not to disallow the said Ordinance has been notified to me through a Secretary of State :

NOW THEREFORE I, JAMES WILSON ROBERTSON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Royal Victorian Order, Knight Commander of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of the Federation of Nigeria do proclaim, and it is hereby proclaimed :

(a) that it is Her Majesty's pleasure not to disallow the Federal Supreme Court Ordinance, 1960 ; and

(b) that the 1st September, 1960, is hereby notified as the day upon which the said Federal Supreme Court Ordinance, 1960, shall come into operation.

**THE MINISTERS' STATUTORY POWERS AND DUTIES (MISCELLANEOUS PROVISIONS) ORDINANCE, 1958 (No. 2 OF 1958)**

**Delegation of Powers**

It is notified that in pursuance of section 3 (1) (a) of the Ministers' Statutory Powers and Duties (Miscellaneous Provisions) Ordinance, 1958, the Minister for Labour has deputed the Permanent Secretary to the Minister or, in his absence, the Deputy Permanent Secretary, to exercise the powers and perform the duties under the Ordinances in the Schedule hereto, subject to the condition that such powers shall be exercised and such duties performed in accordance with any general or special directions given by the Minister.

This delegation is additional to and not a revocation or replacement of the delegations mentioned in section 5 of the Ministers' Statutory Powers and Duties (Miscellaneous Provisions) Ordinance, 1958.

**MINERALS ORDINANCE (CHAPTER 134)**

**Prospecting (Areas and Minerals) Prohibition  
(Amendment) (No. 3) Declaration, 1960**

*Commencement : 25th August, 1960*

**In exercise of the powers conferred by section 8 of the Minerals Ordinance, the Governor-General, after consultation with the Council of Ministers, has made the following declaration—**

Citation.

1. This declaration may be cited as the Prospecting (Areas and Minerals) Prohibition (Amendment) (No: 3) Declaration, 1960.

2. Immediately after paragraph 23 of the Prospecting (Areas and Minerals) Prohibition Declaration, 1946, there shall be inserted the following new paragraphs—
