Customs Tariff (Duties and Exemptions) (No. 6) Order, 1960

Commencement: 22nd September, 1960

In exercise of the powers conferred by subsection (1) of section 6 of the Customs Tariff Ordinance, 1958, the Governor-General, after consultation with the Council of Ministers, has made the following order—

- 1. This Order may be cited as the Customs Tariff (Duties and Exemptions) (No. 6) Order, 1960, and shall be of Federal application.
- 2. The Third Schedule to the Customs Tariff Ordinance, 1958 (which relates to export duties of Customs) as the same was replaced by the Customs Tariff (Duties and Exemptions) Order, 1959, is amended by the addition in item 18 of the following new sub-item:—
  - "(f) Fur, dressed or undressed ... the pound cr part 0 10 0 thereof

THE AIR NAVIGATION (SAFETY OF NAVIGATION)
ORDINANCE (CAP. 8)

The Apapa Landing Ground (Restrictions on user of Land)
Declaration, 1960

Commencement: 22nd September, 1960

In exercise of the powers conferred by subsection (1) of section 3 of the Air Navigation (Safety of Navigation) Ordinance, the Minister of Transport and Aviation has made the following Declaration—

1. This Declaration may be cited as the Apapa Landing Ground (Restrictions on user of Land) Declaration, 1960.

Declared area.

- 2. (1) The following areas are hereby declared to be subject to the restrictions set out in paragraph 3 of this Declaration—
  - (i) all that parcel of land enclosed within a circle having a radius of 4,500 feet and centred at the geometrical centre (namely, the point located at the maximum possible distance from all points upon the external boundary) of the Apapa Landing Ground; and
  - (ii) all that parcel of land enclosed between the circle aforesaid and another circle described about it at a radius of 7,500 feet from the same centre.
- (2) Plans showing the total area of land described in sub-paragraph (1) may be inspected at the Headquarters Office of the Aviation Division of the Federal Ministry of Transport and Aviation at Lagos.

Restrictions.

- 3. (1) Within the area described in sub-paragraph (1) (i) of paragraph 2 of this Declaration no building may be erected, added to or altered, and no tree, plant crop or other vegetation exceeding 15 feet in height may be planted or cultivated, except with the written approval of the Director of Civil Aviation and subject to such conditions as he may impose.
- 2. Within the area described in sub-paragraph 1 (ii) of paragraph 2 of this Declaration, no building exceeding 60 feet in height measured from ground level to the highest part of such building shall be erected and no tree or other obstruction shall be permitted to exceed 60 feet in height.
