Now, THEREFORE, I, SIR JAMES WILSON ROBERTSON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Royal Victorian Order, Knight Commander of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of the Federation of Nigeria, in exercise of the powers in that behalf vested in me and of all other powers me thereunto enabling hereby proclaim that Parliament shall be convened in Lagos: And I do appoint the National Hall as the Senate House for the purposes of the State Opening of Parliament only and thereafter elsewhere as in accordance with established usage: And I do further appoint the time of meeting as the third day of October, 1960, at 8,30 o'clock in the forenoon.

The attendance of Honourable Senators and Members is accordingly requested for the transaction of such business as may be prescribed or offered at the meeting and thereafter as from time to time required.
