

## L.N. 109 of 1961

CUSTOMS AND EXCISE MANAGEMENT ORDINANCE, 1958  
(No. 55 OF 1958)**Exports Prohibition (Amendment) Order, 1961***Commencement : 7th September, 1961*

In exercise of the powers conferred by section 45 of the Customs and Excise Management Ordinance, 1958, the Federal Minister of Finance has made the following Order—

1. This Order may be cited as the Exports Prohibition (Amendment) Order, 1961, and shall be of application throughout the Federation.

Citation and application.

2. The First Schedule to the Exports Prohibition Order, 1959 (which relates to goods absolutely prohibited from being exported from Nigeria) is revoked and replaced by the following—

Amendment of First Schedule L.N. 80 of 1959.

**"FIRST SCHEDULE"**

Goods absolutely prohibited from being exported ;

(i) Explosives, other than industrial explosives.

(ii) Coupons, for foreign football pools or other betting arrangements."

This Order adds certain explosives and coupons for foreign football pools or other betting arrangements to the list of goods absolutely prohibited from being exported from Nigeria.

1. This Order may be cited as the Imports Prohibition (Amendment) Order, 1961, and shall be of application throughout the Federation.

2. The First Schedule to the Imports Prohibition Order, 1959 (which relates to goods absolutely prohibited from being imported into Nigeria) is amended by the insertion, after item 5 thereof, of the following new item—
